3. Reports
 - **President**
 - This past season, we revamped and relocated our **Learn to Skate (LTS)** program which was a big success. Led by Lori Murphy and team, LTS moved from 40 participants on Saturday evening at Centennial to 80 participants on Sunday afternoons at Long Branch.
 - The structure of the programming was revamped with smaller skill-based groups led by some of our teen players who were under the supervision of two Sr. Instructors.
 - Participants received a personalized report card at the end of the season which recommended the appropriate level for the 2025/26 season, encouraging a continuation and progression of skills and we have seen many of them register for this season already.
 - We hosted a FUN 3 team in the second half of the season with 15 players who had a great experience and earned a Gold medal in their loop at the Regional Year-End Tournament.
 - Last year we had 2 teams at 12B, and one at each of 14A, 14B, 16A and 16B.
 - The 14A team earned a place at the Provincial Championships last March
 - ERA developed 6 new Referees; though finding qualified Officials continues to

be a challenge in both LORL and GLRL.

 - 64 adult players in Adult House League with 19 players participating in tournaments
